Do You Know Where Your Kids Are?

This article addresses the recent surge of car break-ins, vandalism and thefts. Over the past few months, many people have reported vandalism to their homes (eggings), Christmas decorations, mail boxes and other personal property along with numerous incidents of theft including personal property, house and auto burglaries.

I personally have witnessed two separate incidents of teenagers approaching my residence. I was fortunate to have been alerted to their presence but was unsuccessful in being able to detain them for the police department. In both incidents, other neighbors were not as fortunate and had their cars burglarized or personal property taken. These two incidents took place during the holiday school break or on a weekend night between the hours of 1am and 4 am. The police responded to both incidents and had even brought the canine unit in an attempt to apprehend these kids. On one occasion, an officer did spot two teenagers at the hump-back bridge but unfortunately could not catch them. On both of these occasions, the suspects fled west into the neighborhood, not east toward US-1. After the second incident, the police said these teenagers are most likely local residents based on two facts: the direction they fled and being spotted in the neighborhood several hours after the police had received the first report of suspicious activity. In addition, the incidents have followed a pattern of occurring on holiday breaks and weekends, leading the police to believe these are young adults or teenagers still enrolled in school.

Over the past decade this neighborhood has seen a substantial influx of younger families moving into our community to raise their children. As time passes, these kids have grown into teenagers and younger adults, as have mine. The challenge of raising small children becomes more consuming as they grow into adults. While some parents may think teens are more mature and independent, this age is the time when in certain aspects they require more supervision and input. Below are some tips provided by law enforcement.

1. Take the time to sit and talk with your kids. Discuss their obligations as young adults with regard to morals, values and consequences of their actions. Talk about peer pressure and what is right and wrong. A good line I once heard was as follows: If you participate in any activity that you cannot come home and tell me about, chances are it is not the type of thing you should be doing.

2. Know where your children are

NRS Sewer Update

n January 7, 2009, Phil Keathley from Martin County Utilities updated us about the vacuum sewer project. The sewer for NRS (514 properties) plus the surrounding communities (about 200 additional residents) has been divided into two phases. Phase 1 contains those properties north of a line defined by the humped-back bridge canal to Half-Mile Lake (near the NRS entrance.) These properties include the north portion of NRS, Sylvan Shores and the Victory homes located around the Pine Lake Golf Course. No action has been taken on the Phase 2 project which includes the NRS homes south of the humped-back bridge canal including 51 homes in Sunset Estates.

Jan/Feb 2009: The drawings for all of the Phase 1 piping have been completed and are being reviewed by MC Utilities. The drawings for the vacuum building on the First Presbyterian Church property are nearly complete. The entire system will be finally reviewed by MC Professional Engineer Ted Robbins. Final site plan approval will be obtained from MC. Phase 1 will be submitted to the Florida DEP for final approval. Pricing will be obtained from qualified contractors.

March/April 2009: A public meeting will be held with all homes affected by Phase 1. Final costs should be known at this time for each homeowner. A \$3million grant has been approved for Phase I of the project, which should reduce the cost to homeowners by approximately 50%.

May/June 2009: The project will be presented to the MC Board of County Commissioners for final approval.



Construction should begin in June 2009 and take one year to complete (June 2010.) The entire construction must be completed before the DEP will issue an acceptance permit. Residential hookups to the system will begin after June 2010 for Phase 1.

In an earlier issue of *The* SCOOP, we reported that the South Florida Water Management District was developing a program to convert old abandoned septic tanks to cisterns for irrigation. The program is still in work. Glen Gareau, NRS resident and SFWM engineer, recently reported that a prototype cistern system is being built in Stuart. More information will be forthcoming on this program later in the 2009 year. The potential for grant money to help residents convert their septic tanks is still in development by the SFWMD.

2008 was another good year for the Association from a financial perspective. We were able to operate the Association, keep our front entrance, parks and boat ramp maintained and reserve funds for future maintenance, dredging and other capital improvements.

With member annual assessments, non-member boat ramp user fees (reduced to \$175 in 2009) and donations from members and non-members alike, the Association has the financial means to continue to maintain and improve our beautiful neighborhood.

I give my thanks to all who have been diligent in paying your annual assessments. As I mentioned at the November Annual Meeting, I will not be as lenient this year (as I was in 2008) when collecting past due assessments. A late fee of \$25 will be charged as of February 1 and interest will begin accruing on that date as well. Non-payers will face small claims court action and will have to pay the assessment, late fee and interest, legal and court fees. I truly hope we don't have any members in this category.

North River Shores Property Owners' Association Minutes for Annual Meeting — 11/13/2008

Welcome and Introductions:

At 7:05 PM, NRSPOA President **Tom Lusty** called the meeting to order and welcomed Association members. After an Invocation by Pastor Doug LaPointe and the Pledge of Allegiance, Tom stated the meeting's objective is to conduct the Association's annual business in preparation for 2009. He summarized the rules of order for members wishing to address the meeting later.

Tom Lusty (President; Editor of *The SCOOP*) introduced the 2008 Board members and their committee assignments: **Hal Halliburton** (Vice President; deed restrictions and boat ramp), **Trish Littman** (Secretary; *The SCOOP*), **Sean Fenniman** (Treasurer; budget, finance and insurance), **Bob Anderson** (social events), **Jason Schwartz** (membership, covenants sign-up and communications), **Pete Meier** (government and public relations), **George Milne** (nominations), and **Chuck Wallenhorst** (maintenance, special projects and dredging).

Tom also recognized non-Board members for their outstanding volunteer work for the Association: Suzy DiBartolo (landscape maintenance and beautification), Jan Stoorza (phone communications), Cathy Ellis (NRSPOA historian), Jim Rizzolo (liaison to NRSPOA's Web Master), Deanna Thurlow (layout artist for *The SCOOP*), Chris Meier (editing *The SCOOP*), Bob Wright (boat ramp keys), Colleen Patterson and Kathryn Kaidy (temporary secretary, local community issues), Fred and Jerry Felton (Neighborhood Watch).

Announcements:

Tom Lusty announced that the year-end financial summary and minutes of this annual meeting will be published in the first 2009 issue of *The SCOOP*. He also invited members to volunteer for Neighborhood Watch, social events, and the initiative seeking business discounts for members.

New Business:

Three Board positions, each with a three-year term, will be open for 2009 because of expiring terms (Jason Schwartz, George Milne, and Pete Meier). The president introduced the slate of nominees for those three positions: Jeff Duckworth, Pete Meier, Colleen Patterson, and Mike Edwards. He then called for nominations from the floor. When none came forward, Cathy Ellis made a motion, seconded by Richard Pontynen, to close nominations. The motion passed unanimously.

Opening discussion of the proposed 2009 budget, Treasurer Sean Fenniman noted no significant or unexpected expenses in 2008. The 2009 budget presumes payments from all 347 members eligible for assessments plus 29 non-member boat ramp users. He said if the proposed budget is approved, the annual assessment for 2009 will be only \$175 per member or ramp user, down from \$185 in 2008. Correcting some misinformation, Sean stressed dues are obligatory. He said members had a 7.5% non-payment rate in 2008. If all members pay their assessment, further reductions are possible in the future. He promised to be much less lenient with delinquent accounts in 2009. Responding to a question from Richard Pontynen, Sean said the POA cannot comingle annual fees from the members with annual boat ramp fees from the non-member boat ramp users.

Tom Lusty summarized the three ballots and one non-binding resolution open for vote. **Ballot #1**, a proposed amendment to Article II Section 2 of the Second Amended Bylaws for North River Shores, would remove current ambiguity in the way members in good standing are elected to serve on the NRSPOA Board of Directors. The new wording, approved by the current Board and reviewed by the POA attorney, continues the practice of voting "Yes" or "No" for each candidate. If approved by the membership, this amendment would take effect for this election. Tom added that all Bylaw amendments require a super quorum — 30% (or 98) of the 324 members presently eligible to vote. *Editor's Note: Ballot #1 passed, 91% yes to 9% no.*

Ballot #2, for election of three new Board members, each with a three-year term, presented the four candidates, their brief biographies, and boxes to vote "Yes" or "No" for each. *Editor's Note: Jeff Duckworth, Mike Edwards and Colleen Patterson were elected to the Board.* **Ballot #3** represented the vote for the proposed 2009 budget. *Editor's Note: the 2009 budget passed 97% yes to 3% no.*

The Non-binding Referendum asked whether members would support a change in the Covenants about the types of trucks permitted in NRS. Members would indicate their opinion about a focus on the appearance rather than on the weight of trucks. Tom stressed the referendum was not an actual vote, just guidance for the Board. Editor's *Note: the majority of members favored the non-binding referendum*, 85% yes to 15% no.

After the president repeated voting instructions, members who had not yet voted placed their sealed ballots in the official ballot box held by Jim Rizzolo.

Bob Wright was the first member to address the audience. An 11-year resident of NRS, former Board Vice President, and current volunteer guardian of the boat ramp keys, Bob is also a Martin County Sheriff. He cautioned members about rising crime rates during the economic downturn, advising residents to lock up vehicles, houses and boats. Bob urged attention to suspicious activities and to foreclosed homes, asking members not to be afraid to call 911 if they observe suspicious activity.

Jerry Felton described Neighborhood Watch (NW) as part of the Sheriff's department (NW is not part of the NRSPOA). NRS residents since about 1980, Jerry and Fred organize the schedule. She called Neighborhood Watch a "psychological" presence in our community; she also emphasized calling 911 rather than getting involved in anything unusual or suspicious. Jerry urged members to volunteer for about one hour once a month.

Bob Anderson, chairman of the Board's social committee, told members about the signs he posts around NRS reminding residents about upcoming NRSPOA events. He described upcoming events such as the Holiday Cookie Exchange, the winter "Snow Storm" January 9 in Lakeside Park, and the Mardi-Que community picnic in March. Bob also asked residents to volunteer for those events.

Tom Lusty thanked members for attending and participating in the annual meeting, and invited all to share the refreshments and sign up for various committees. Bob Wright made a motion to adjourn at 8:05 PM, seconded by Jim Rizzolo. A unanimous voice vote carried the motion.

Burglaries were the main topic of both the December and January NEIGHBOR-HOOD WATCH COM-MUNITY meetings. Laura Passanesi, Community Programs Practitioner, empha-

sized both house and car burglaries are occurring in Martin County. Laura hopes that you have written down the serial numbers of all your valuables such as TV sets and computers. Should these items be stolen, you have a better chance of retrieving them. It was also mentioned that items might even be returned to you after several years if you have given the police the serial numbers. If you have pictures of your stolen jewelry, you will have a higher chance of retrieval. At the January 8 meeting, Detective Carlo Sciandra portrayed a thief and program attendees analyzed the situation. If you are a victim of a burglary, Detective Carlo emphasized how important it is to be observant of the thief's voice, height and weight. What the burglar is wearing is not important because the burglar can easily change his/her clothes. Detective Carlo also said NEVER be afraid to call 911. He said that we should consider asking Laura Passanesi to do a house safety evaluation. This service is free. You can make a reservation for this house safety evaluation by calling Laura at 320-4749.

Laura Passanesi also directs the "Citizens Academy" course. We took this class several years ago and highly recommend it. You will see the Sheriff's offices in action and learn more about Martin County. Call her if you are interested.

2009. He estimates the job should be completed by the end of this month.

The fill from the dredging will be deposited, at no cost to the project, at several sites within the North River Shores boundaries. There may be times during the dredging operation that boat traffic using the waterway will be delayed. Hang in there, boaters! We will try our very best to keep you informed.

After a week of cold weather, we were able to get out and fish. The water temperatures were way down but it helped to put us back in the winter fishing pattern. The Spanish mackerel returned to Peck's Lake in great numbers. We limited out in no time the other day. Bluefish are all around the inlet and we had a great time catching them on light tackle. The pompano bite, which had virtually disappeared, turned on again. Sailfish and dolphin are being caught in decent numbers once again. On a recent trip we were in acres of threadfin herring with jumbo jacks pounding through them. We had a rod bending time bringing these tough fish to the boat. The bottom bite at the Loran Tower has also been great. We limited out on vermillion snapper and had a bunch of nice sized porgies on our last trip there. Triggerfish and several small grouper were also in the mix. Look for pompano at the Stuart Causeway and on the flats near the St. Lucie inlet. Shrimp-tipped jigs or sand fleas will do the trick. Snook season opened February 1, so get out there and catch'em up.

and who they are with. If they are spending the night at a friend's house, contact the parents and be sure they will be under parental supervision while there.

3. Set parameters such as curfew hours as well as phone and computer use time restrictions.

4. This may be the hardest to imagine because it takes dedication and a bit of distraction from the parents routine. Tell your children that you will be checking on them at random periods of the night especially when they are have friends staying over or on weekends and then follow up by doing exactly that. Fluctuate the times that this is done and don't be afraid to do so more than once a night. Your children are smart. If this is done on a regular basis, they will not know when or how many times you may check on them, making it less likely that they will attempt to venture out in the middle of the night.

As parents we have an obligation to our children, ourselves, friends and neighbors to help guide our kids down the right path. As a neighbor, I encourage all parents to take the time to know where their kids are, what they are feeling and who they consider to be their friends. Parenting is a tough, full-time commitment that does not come with operating instructions. All we can hope for is the strength and desire to raise our children to the best of our ability.

I also spoke with the police department about how homeowners can better protect themselves against these types of crimes. Below are a few of their suggestions.

1. Do not leave valuables in your vehicles.

2. Lock your vehicle at all times both day and night.

3. Do not leave personal property out when not in use - such as bicycles, toys, fishing gear, etc.

4. Install motion detector lighting around the exterior of your house.

5. Install outdoor sensors that alert homeowners to the



presence of someone on your property.

6. Install digital security cameras. Today's technology allows for this type of protection at affordable prices. Digital systems allow up to 3 weeks of data storage for retrieval if needed.

7. Be diligent in your awareness of your surroundings.

8. Know and cooperate with your neighbors. Look out for each other.
